The Investment Option produced an exceptional return for the September quarter as domestic property markets continued to surge.

Market Review

Australian listed property powered higher over the September quarter, delivering double digit returns and comfortably outperforming broader Australian shares, driven largely by markets anticipating future domestic interest rate cuts.

Outlook

We believe the Australian listed property sector will continue to be supported by stable income streams over the long-term, though we expect further volatility is likely in the current inflation and interest rate-focussed environment.
