Target Market Determination 30 September 2024

This Target Market Determination (**TMD**) is required under section 994B of the *Corporations Act 2001* (Cth) (**the Act**). This TMD describes the class of consumers that comprises the target market for the financial product and matters relevant to the product's distribution and review (specifically, distribution conditions, review triggers and periods, and reporting requirements). Distributors must take reasonable steps that will, or are reasonably likely to, result in distribution of the product being consistent with the most recent TMD (unless the distribution is excluded conduct).

This document is **not** a product disclosure statement (**PDS**) and is **not** a complete summary of the product features or terms of the product. This document does not take into account any person's individual objectives, financial situation or needs. Persons interested in acquiring this product should carefully read the PDS for the product before making a decision whether to buy this product.

Target Market Summary

This product is intended for a consumer who is seeking capital preservation and potentially some income distributions. It has a medium risk/return profile and is intended for use up to a standalone solution of an investment portfolio.

It is likely to be consistent with the financial situation and needs of a consumer with a minimum investment timeframe of 3 years and who is unlikely to need to withdraw their money on less than one week's notice.

Appropriateness

Investment products and diversification

Significant dealings	Section 994F(6) of the Act requires Distributors to notify the Issuer if they become aware of a significant dealing in the product th is not consistent with the TMD. Neither the Act nor ASIC defines when a dealing is 'significant' and Distributors have discretion t apply its ordinary meaning. The Issuer will rely on notifications of significant dealings to monitor and review the product, this TMD, and its distribution strateg and to meet its own obligation to report significant dealings to ASIC. Dealings outside this TMD may be significant because:	
	 they represent a material proportion of the overall distribution conduct carried out by the distributor in relation to the product or they constitute an individual transaction which has resulted in, or will or is likely to result in, significant detriment to the consum (or class of consumer). In each case, the Distributor should have regard to: 	
	 the nature and risk profile of the product (which may be indicated by the product's risk rating or withdrawal timeframes), the actual or potential harm to a consumer (which may be indicated by the value of the consumer's investment, their intended product use or their ability to bear loss), and the nature and extent of the inconsistency of distribution with the TMD (which may be indicated by the number of red and/or amber ratings attributed to the consumer). Objectively, a Distributor may consider a dealing (or group of dealings) outside the TMD to be significant if: 	
	 it constitutes more than half of the distributor's total retail product distribution conduct in relation to the product over the quarter, the consumer's intended product use is <i>solution/standalone</i>, or the consumer's intended product use is <i>core component</i> or higher and the consumer's risk/return profile is <i>low</i>, or the relevant product has a green rating for consumers seeking <i>extremely high</i> risk/return.
